1. **ALL applicants must complete the entire form.**
2. Applicants applying for a renewal of Licence must complete and supply names of two (2) referees of work carried out. A Renewal Fee of \$500.00 plus VAT must be paid.
3. All First Issue applications MUST be submitted with a non-refundable fee of five hundred dollars plus VAT (\$500.00 + VAT), payable to WASA Head Office's cashiers together with the following:
 - (i) **Original and one copy of birth certificate**
 - (ii) **Original and one copy each of certificates of achievement**
 - (iii) **Two recent (six months) letters of recommendation**

REQUIREMENTS:

In order to qualify for the grant of a Sanitary Constructor's Licence **all applicants must be 21 years and over** and meet one of the following combinations of qualification and experience.

- (i) Qualification and Experience
 - a) A Craftsman Diploma in Plumbing issued by the Ministry of Education and a minimum of five (5) years experience working with a Licensed Sanitary Constructor. A minimum of two (2) years experience must be attained on completion of the craftsman Diploma.
 - b) A City and Guilds of London Final Certificate in Plumbing. A five (5) years apprenticeship period forms part of this programme.
 - c) A Master Plumber Certificate from USA & Canada. The Master Plumber Certificate includes a five (5) year apprenticeship period.
 - d) Degree in Civil Engineering and experience in plumbing and associated works. Applicants with other engineering degrees may be considered based on their experience in the plumbing field.
 - e) The attainment of supervisory level (Foreman II and above) in the Operations or Capital Investment Division and ten (10) years experience in plumbing supported by a statement of good performance and conduct while in the employ of the Authority.
- No Licences Will Be Granted To Applicants While In The Employ Of The Authority.**
- f) Five (5) years plumbing experience working with a Licensed Sanitary Constructor and at least one of the following.
 - (i) The Craftsman Assistant certificate in Plumbing from the Ministry of Education obtained at the National Youth Camps (duration of course at least 1000 course hours.)
 - (ii) The UWI Extra Mural Course in Plumbing (duration of Course at least One (1) academic year).
 - (iii) Applicants with qualifications equivalent to (i) and (ii) shall be required to sit a written examination developed and administered by the Authority's Center for Manpower Development.

Only applicants who meet the above requirements shall be interviewed or considered for a waiver of the interview process.
